## ANIMA Holding: July 2024 net inflows

- Net inflows (ex Class I insurance mandates): € +973 million
- Total AuM at the end of the month €201.7 billion

"The July figure is an outstanding combination of very good inflows from retail, continuing and even improving the year-to-date trend, and two new welfare mandates resulting from consistent efforts, the results of which are concentrated in a single month as is typical of the institutional business" – commented Alessandro Melzi d'Eril, Chief Executive Officer of ANIMA Holding – "The month also includes a positive contribution from both Castello and Kairos, which is higher than the group average and aligned with the strategic goals communicated to the market"

Net inflows into managed assets recorded by ANIMA Group in the month of July amounted to € +973 million (ex class I insurance mandates).

To allow for a better evaluation of the economic effect of net inflows, since January 2024 ANIMA discloses the component related to **funds underlying funds**, whose profitability is limited and in many cases cancelled by the prohibition of fee duplication, as per Italian regulations.
