## ANIMA Holding: October 2024 net inflows

- Net inflows (ex Class I insurance mandates): € +4 million
- Total AuM at the end of the month €201.2 billion (€202.2 billion including administered assets)

"The quality improvement of our assets under management is confirmed by October's figures, with outflows concentrated in low-economic-impact categories" commented Alessandro Melzi d'Eril, CEO of ANIMA Holding. "Conversely retail inflows, positive every month since the beginning of the year, have significantly exceeded 2 billion euros."

Net inflows into managed assets recorded by ANIMA Group in the month of October amounted to € +4 million (ex class I insurance mandates).

To allow for a better evaluation of the economic effect of net inflows, since January 2024 ANIMA discloses the component related to **funds underlying funds**, whose profitability is limited and in many cases cancelled by the prohibition of fee duplication, as per Italian regulations.
