CONSOB APPROVA IL PROSPETTO INFORMATIVO RELATIVO ALL'AUMENTO DI CAPITALE IN OPZIONE

Milano, 22 marzo 2018

Anima Holding S.p.A. (l'"Emittente" o la "Società") rende noto che, in data odierna, Consob ha approvato il prospetto informativo (il "Prospetto Informativo") relativo all'offerta in opzione e all'ammissione alle negoziazioni sul Mercato Telematico Azionario, organizzato e gestito da Borsa Italiana S.p.A. ("MTA"), delle azioni ordinarie dell'Emittente rivenienti dall'aumento di capitale in opzione.

Come già comunicato, i diritti di opzione che daranno diritto alla sottoscrizione delle azioni ordinarie dell'Emittente di nuova emissione (i "Diritti di Opzione") dovranno essere esercitati, a pena di decadenza, a partire dal 26 marzo 2018 entro il 12 aprile 2018, estremi inclusi (il "Periodo di Opzione"). I Diritti di Opzione saranno inoltre negoziabili sul MTA dal dal 26 marzo 2018 al 6 aprile 2018, estremi inclusi. I Diritti di Opzione non esercitati entro il 12 aprile 2018 saranno offerti dalla Società sul MTA entro il mese successivo alla fine del Periodo di Opzione per almeno 5 giorni di mercato aperto, salvo che non siano già stati integralmente venduti, ai sensi dell'articolo 2441, comma 3, del Codice Civile (l'"Offerta in Borsa"). Le date di inizio e di chiusura del periodo di Offerta in Borsa verranno comunicate al pubblico mediante apposito avviso, pubblicato su almeno un quotidiano a diffusione nazionale e sul sito internet dell'Emittente www.animaholding.it.

Il Prospetto Informativo sarà reso disponibile al pubblico presso la sede legale della Società (Corso Garibaldi n. 99, Milano) e sul suo sito *internet* (<u>www.animaholding.it</u>). L'avvenuta pubblicazione sarà resa nota al pubblico nei modi e nei termini di legge.
